- 1. The above recitals are true and correct;
- 2. The Board of Directors hereby adopts the report of election results of the 2019 Proposition Election, which is attached hereto and incorporated herein for all purposes, provided by the independent election auditor as the official election results for the 2019 Proposition Election;
- 3. The official election results provide that the Weston WSC Members have voted AGAINST the proposition by the requisite majority under Section 22.164(b)(1) of the Texas Business Organizations Code.
- 4. The Board of Directors hereby authorizes the Credentials Committee, Weston WSC representatives, and Weston WSC legal counsel to take any and all actions required for implementing this resolution in furtherance of the newly elected Board members to take office.
